7. DOCUMENTS REQUIRED PRIOR TO OBTAINING AN AUTHORIZATION CERTIFICATE

The request for filling and backfilling work must be submitted with a plan showing:

- a) the dimensions and the area of the land;
- b) the location of servitudes, street lines, buildings, water courses, lakes, swamps and wooded areas;
- c) the existing topography of the sides or altitude lines;
- d) the proposed levelling in comparison with the street and adjacent lots;
- e) the motives for the foreseen work;
- f) the method of construction, the materials used, the dimension and the location of the work and the proposed usage.
- g) The localisation plan of the work area with the exact distance between the building, the work area and any elements that could affect the understanding of the type of construction, the extent of the construction, etc.

In the case of work in wet zones, all filling, backfilling, soil excavation or the displacement of humus as well as any construction works are prohibited unless the request is accompanied by an environmental impact study prepared by an accredited professional and with an authorization certificate from the minister du Développement durable, de l'Environnement et des Parcs, under the terms of article 22 of the Law on quality of the Environment.

8. FEES

The cost of the authorization certificate for a filling and backfilling permit request is \$ 40.00, except the authorisation for a private entrance. These fees must be paid when depositing the request.

9. DELAY

Please foresee a delay of 15 to 45 days for obtaining an authorization certificate.
