6.2 POTENTIALLY DANGEROUS DOG

2022-04-R068

WHEREAS the Government of Quebec has adopted the By-Law respecting the application of the Act to promote the protection of persons by establishing a framework regarding dogs;

WHEREAS by this By-Law, the municipalities are responsible for the application of the provincial By-Law on their territory;

WHEREAS article 9 of this by-law stipulates that a dog which has bitten or attacked a person or a domestic animal and has inflicted an injury on them may be declared potentially dangerous by a local municipality;

WHEREAS the municipality has the responsibility to see to the protection of all persons on its territory;

WHEREAS a complaint has been filed with the Municipality of the Township of Harrington, following bites inflicted on several people by a dog which appears to be of the German shepherd breed, residing on the territory;

WHEREAS this dog is under the responsibility of a citizen residing at 49, chemin Thompson, roll number 2086-81-7908;

WHEREAS the municipality must inform the owner or custodian of the dog of its intention to declare the dog potentially dangerous as well as the reasons on which it is based and indicate to him the time limit within which he can present his observations and, if nécessary, produce documents to complete his file;

THEREFORE it is moved by Councillor Daniel St-Onge and unanimously resolved

- **THAT** the municipality inform the owner or custodian of the dog residing at 49 Thompson Road, roll number 2086-81-7908 of its intention to declare the dog potentially dangerous considering that the dog has already bitten two (2) people, including a child, in recent weeks and inform him that he can present his observations and, if necessary, produce documents to complete his file, until May 4, 2022;
- **THAT** pending the final decision, which will be taken at the regular sitting of the municipal Council of May 9, 2022, the municipality of the Township of Harrington order the owner or guardian of the dog residing at 49, chemin Thompson, roll number 2086-81-7908 to comply with the following measures at the latest on May 9, 2022:
 - **THAT** the dog wears a basket muzzle at all times and is held by a leash no longer than 1.25 meters;
 - **THAT** the dog be guarded by means of a device that prevents it from leaving the limits of the owner's land, in addition to affixing a poster in a place allowing to announce, to a person who presents himself on the owner's land , the presence of the dog;
 - **PROHIBIT** the dog from being in the presence of a child 10 years of age or under without the dog being under the constant supervision of an adult;
 - **THAT** the dog's current rabies vaccination status be up to date.

WHEREAS this by-law is adopted in accordance with the second paragraph of article 1061.1 of the Municipal Code of Quebec or the second paragraph of the third paragraph of article 567 of the Cities and Towns Act;

WHEREAS the confirmation of the grant from the Ministère des Transports du Québec dated September 4, 2020, in order to allow the repair work on chemin de la Rivière-Rouge;

WHEREAS the grant is paid over a period of ten (10) years;

WHEREAS it is necessary to borrow the sum of \$670,200;

WHEREAS the notice of motion was duly given at the Council sitting held on February 14 and the draft bylaw was tabled at the same sitting;

THEREFORE, it is moved by Councillor Gerry Clark and resolved to adopt By-law number RE-293-2022 decreeing a loan of \$670,200 to finance the subsidy from the ministère des Transports granted under the Programme d'aide à la voirie locale - Volet redressement des infrastructures routières locales (RIRL) and decreeing a loan to defray the cost.

BY-LAW NO RE-293-2022 DECREEING A LOAN OF \$670,200 TO FINANCE THE GRANT FROM THE MINISTRY OF TRANSPORT AS PART OF THE LOCAL ROADS AID PROGRAM, COMPONENT -INFRASTRUCTURE RECOVERY LOCAL ROADS (RIRL)

WHEREAS this By-law is adopted in accordance with the second paragraph of article 1061.1 of the Municipal Code of Québec or the second paragraph of the third paragraph of article 567 of the Cities and Towns Act;

WHEREAS the confirmation of the subsidy from the Ministère des Transports du Québec dated September 4, 2020, in order to allow the repair work on chemin de la Rivière-Rouge;

WHEREAS the grant is paid over a period of ten (10) years;

WHEREAS it is necessary to borrow the sum of \$670,200;

WHEREAS the notice of motion was duly given at the Council sitting held on February 14 and the draft Bylaw was tabled at the same sitting;

THEREFORE the Council decrees by by-law RE-293-2022 decreeing a loan of \$670,200 to finance the subsidy from the Ministère des transports granted under the local road assistance program, component - road infrastructure rehabilitation (RIRL), as follows:

ARTICLE 1. The preamble is an integral part of the By-Law.

ARTICLE 2. In order to finance in full the amounts provided for in the subsidy from the Ministère des Transports du Québec within the framework of the local road assistance program, component - recovery of local road infrastructures (RIRL), the municipality is authorized to borrow up to the sum of \$670,200 for a period of ten (10) years.

ARTICLE 3. The municipality will provide, during the term of the loan, for the expenses incurred in relation to the interest and the capital repayment of the annual installments, by appropriating each year the subsidy from the Ministère des Transports du Québec, in accordance with the payment schedule transmitted by the said ministry, on January 30, 2022 attached to this By-Law to form an integral part thereof.

ARTICLE 4. To provide for the balance of the expenses incurred in relation to the interest and capital repayment of the annual installments of the loan, it is imposed by this regulation and it will be deducted, annually, during the term of the loan, from all taxable immovables situated on the territory of the municipality, a special tax at a sufficient rate according to their value as it appears on the assessment roll in force each year.

ARTICLE 5. This By-Law will come into force in accordance with the law.

11.1 SUBSCRIPTION TO THE GROUP INSURANCE PROGRAM OF THE FÉDÉRATION QUÉBÉCOISE DES MUNICIPALITÉS AND TO A GROUP INSURANCE CONTRACT

WHEREAS the Fédération québécoise des municipalités (hereinafter the "FQM") has set up a group insurance program governed by one of its By-LawS (the "Program");

WHEREAS to this end, the FQM issued a call for tenders bearing number FQM-2021-002 dated July 5, 2021;

WHEREAS to follow up on this call for tenders process, the FQM has become the Policyholder of a group insurance contract with Desjardins Financial Security, life insurance company (hereinafter: the "Contract");

WHEREAS the FQM has mandated its subsidiary FQM Assurances Inc., broker in group insurance, the mandate to see to the application of the Contract and to advise the municipalities, their officials and employees and the members of the municipal Councils as to all questions where a broker's license is required under the Act respecting the distribution of financial products and services, c. D-9.2;

WHEREAS under the Municipal Code of Quebec and the Cities and Towns Act, a municipality, a MRC or a municipal body may adhere, for the benefit of its officials and employees and members of its Council, to an insurance contract collective whose Lessee is the FQM;

WHEREAS the Contract entered into force on January 1, 2022;

WHEREAS the Contract is automatically renewable every year;

THEREFORE, it is mpved by Councillor Julie James and resolved

- THAT the Municipality of the Township of Harrington adhere for the benefit of its officials and employees and members of the municipal Council to the Program and is governed by the Contract of June 1, 2022;
- **THAT** the Municipality of the Township of Harrington pay the premiums for the year of coverage as well as all premiums and premium adjustments for each subsequent insurance year;
- **THAT** the Municipality of the Township of Harrington respects the terms and conditions of the Program and the Contract;
- THAT the Municipality of the Township of Harrington maintain its participation in the Program by subscribing, without additional formality, to any group insurance contract concluded by the FQM to respond to a call for tenders to replace the Contract and by respecting terms and conditions;
- THAT the Municipality maintain the insurance coverage provided for in the Contract or in any contract replacing it, and this, until the Municipality terminate, in accordance with the Bylaw, its participation by sending the FQM a written notice of at least one (1) year mentioning his intention to no longer participate in the Program;
- **THAT** the Municipality of the Township of Harrington empower its Director General to perform any act and transmit any document resulting from the Municipality's adherence to the Contract or any contract replacing it;
- **THAT** the Municipality of the Township of Harrington authorize FQM Assurances Inc. and any firm of consulting actuaries designated by the latter, to have access to its group insurance file with the insurer in compliance with the rules for the protection of personal information;
- THAT the Municipality of the Township of Harrington grant FQM Assurance Inc. and any firm of consulting actuaries designated by the latter, the mandate to act as expert advisor and exclusive broker in group insurance and that they be the only persons appointed and authorized to represent it with the designated insurer with respect to the application of the group insurance plan;
- **THAT** this resolution in no way limits the right of the FQM to revoke its designated representatives and substitute another;
- **THAT** this resolution be immediate and revoke any other resolution previously granted on the same subject as this resolution, without further notice.

11.2 AUTHORIZATION TO SIGN A SERVICE AGREEMENT WITH THE NEXT GENERATION 9-1-1 AUTHORITY

WHEREAS Next Generation 9-1-1 Service (as defined below) replaces Enhanced 9-1-1 Service ("9-1-1 E") and is based on protocol technologies Internet (IP) and supports native end-to-end IP 9-1-1 calling;

WHEREAS the Canadian Radio-television and Telecommunications Commission (the "CRTC") determined in Telecom Decision CRTC 2015-531 that Canada's NG9-1-1 system should follow the National Emergency Number Association standard (the "NENA i3 Standard");
