Harrington Territory Fire Department Tour

THE FIRE DEPARTMENT WILL BE ON TOUR DURING THE MONTH OF AUGUST

The Harrington fire brigade will be knocking on the doors of homes to confirm the presence of smoke alarms, provide advice and answer questions from the public related to fire prevention.

Residential tours are conducted by two young students. They will be easily recognizable by their uniform in the colors of the Harrington Fire Department. Hired for the summer season, these students will make their rounds during the month of August.

This annual process is a privileged way to raise public awareness on protective measures and preventive actions.

In particular, they will remind residents that each home must have one functional smoke detector per floor, will remind residents of the importance of having portable fire extinguishers and carbon monoxide detectors, in addition to answering citizens questions. A recommendation form will be sent following their visit.

"Our goal is to reduce the risks related to fires as much as possible and it all starts with prevention", points out the director of the fire departement, Neil Swail. "Also, we want to reassure citizens: the firefighters are not there to sell them anything. REGISTRATION FOR MUNICIPAL ALERT SERVICES

As part of its emergency plan, residents of Harrington can now be contacted by an automated emergency messaging system operated by the municipality, WITHOUT ANY CHARGES TO CITIZENS.

This system is supported by the Telmatik contact center. It is in operation 24 hours a day, 365 days a year and makes it possible to quickly reach all citizens in order to keep them informed of any particular situations. Through this innovative communication tool, citizens can receive a wide range of information such as: emergency messages, service interruptions, general notices, events or any other situation deemed urgent.

The telephone service currently has a list of telephone numbers compiled from the telephone directory. If you don't have a landline, we suggest you sign up. The system allows multiple registrations for the same address and allows you to choose the desired mode of communication (phone call, email or text messaging).

It is important for citizens and merchants to keep their information up to date. The information provided during your registration remains confidential and will only be used for the purposes of the emergency alert service. It is possible to unsubscribe from alerts at any time by deactivating your account.

Boat washing before launching

YOUR RESPONSIBILITY AND AN OBLIGATION TO PRESERVE OUR LAKES!

Anyone wishing to launch a boat, whether from private land or public access, must go to the municipal boat wash station and clean their boat. This will ensure the preservation of our lakes.

All boaters who do not comply with the obligation to wash their boat expose themselves to a fine of \$500 to \$2,000 imposed by the municipality.

THE BOAT WASH STATION IS LOCATED AT 2811 ROUTE 327 (AT THE FIRE STATION).

FIRE PREVENTION THERE'S NO SMOKE WITHOUT FIRE! A NEW BY-LAW PUT IN PLACE

What a joy to rediscover the joys of a good outdoor fire, with family or friends. Did you know that the use of an outdoor fireplace is regulated in Harrington, and that a new regulation has recently been adopted, in regards of fire prevention?

A permit is not required for ambient fires (campfire). When you make an outdoor fire to chase off mosquitoes, brighten up a picnic or even when camping, the following conditions must be respected. The ambiance fire can only be lit or kept lit in the various following spaces:

- An outdoor fireplace specially designed for this purpose having a chimney and a spark screen;
- A non-combustible container;
- A stone or brick fireplace with a spark screen;
- A hole dug in the ground having a minimum depth of fifteen (15) centimeters, moreover it must be surrounded by stones or bricks of at least fifteen (15) centimeters in height;
- An outdoor cooking appliance or equipment designed for this purpose, such as a barbecue, appliance or camping equipment.

In addition, ambient fires must comply with the following constraints:

- The size of the fire cannot exceed one (1) meter by one (1) meter;
- The height of the fire cannot exceed one (1) meter;
- No fire is authorized if the wind speed exceeds 20 km/h;
- No fire is authorized if the SOPFEU fire danger index is extreme (red);
- Have at least one responsible adult on the premises;
- Have fire extinguishing facilities at all times.

A MUNICIPAL PERMIT IS REQUIRED

For all other types of fire, a free municipal permit is required. Please contact the Municipality staff directly for more details.

For more details consult our website: www.harrington.ca/en/municipality/municipal-by-laws When lit, an outdoor fire must be constantly supervised by an adult, until it has been extinguished in such a way that it no longer constitutes a fire hazard. Remember that the ashes can stay hot for seven days.

It is forbidden to make a fire outside on days when the wind speed and gusts exceed twenty (20) km/hour.

The person responsible for the fire must at all times check the fire danger index with the Société de protection des forêts contre le feu (SOPFEU) http://sopfeu.qc.ca

MAYORS 'REPORT ON HIGHLIGHTS OF THE FINANCIAL REPORT AND AUDITOR'S REPORT OF THE MUNICIPALITY OF THE TOWNSHIP OF HARRINGTON - YEAR 2021

Dear Citizens,

It is with pleasure that I present the highlights of the financial report and the report of the auditor of the Municipality for the year 2021, in accordance with article 176.2.2 of the Municipal Code of Québec.

FINANCIAL REPORT AND REPORT OF THE INDEPENDENT AUDITOR AS AT DECEMBER 31st, 2021

First, for the fiscal year ended December 31st, 2021, the revenues of the municipality amounted to \$ 4,178,663 while the expenses amounted to \$ 2, 891,648, which led to a surplus of \$ 1,284,015. Taking into account the investment income (debit) of \$ 676,539, the operating deficit for the fiscal year before reconciliation for tax purposes is \$ 610,476. Once this reconciliation for tax purposes was carried out, we have a surplus of \$ 864,055. At the end of fiscal year 2021, the long-term debt of the Municipality was \$ 3,008,400. As for the surplus at December 31st, 2021, the Municipality ends the fiscal year 2021 with a unallocated operating surplus of \$ 1,375,095 and an allocated operating surplus of \$ 1,183,870. The independent auditor, Gariépy Buissière CPA inc., has audited the financial statements of the Municipality of the Township of Harrington as at December 31st, 2021, as well as the results of the financial statements of its operations, changes in its net financial assets (net debt) and cash flows for the year then ended, in accordance with Canadian public sector accounting standards.
