BY-LAW CONCERNING THE RENUMERATION OF THE ELECTED MUNICIPAL OFFICERS

THE MUNICIPAL COUNCIL DECREES THE FOLLOWING:

WHEREAS an Act respecting the remuneration of elected municipal officers (R.S.Q., c T-11.001) specifies the powers of Council in the fixed in remunerations;

WHEREAS Council wants to adopt a By-Law concerning the remuneration of the elected municipal officers and wants to foresee the payment of transition allocation to certain people;

WHEREAS the Municipality of the township of Harrington is governed by By-Law concerning the remuneration of the elected municipal officers, however, in the opinion of Council, there is a need to bring up to date the said By-Law and to render it more conformed to to-day's cost of living;

WHEREAS a notice of motion was given by councillor, Mr. Claude La Roque on May 2, 2011, for said By-Law;

THEREFORE, moved by councillor Claude La Roque, seconded by councillor Randy Watson and resolved by a majority that the Council of the Municipality of the Township of Harrington decree and order the by law, and that it be hereby enacted and ordered, as follows:

ARTICLE 1:

The preamble is an integral part of the said By-Law.

ARTICLE 2:

The present By-Law replaces By-Law 155-2004, and its amendments.

ARTICLE 3:

The present By-Law sets the basic annual remuneration for the Mayor and each Councillor of the Municipality of Harrington for the fiscal year of 2011 and the following fiscal years.

ARTICLE 4:

The basic annual remuneration for the Mayor will be set at \$11 560.00 and that each councillor will be set at \$3 853.33.

ARTICLE 5:

In the case where the Acting Mayor replaces the Mayor for more than thirty (30) days, the Acting Mayor has the right, from that moment, up until the end of the replacement, to a sum equal to the remuneration of the Mayor during this period.

ARTICLE 6:

Further to the remuneration set above, each elected is entitled to an expense allowance of an amount equal to one half of the amount of that remuneration, regardless of the excess amount referred to in Section 20 of *An Act Respecting the Remuneration of Elected Municipal Officers*, up to the maximum prescribed under section 22 of this Law.

However, where the amount equal to one-half of the amount of the mayor's remuneration under sections12 and 13 of An Act Respecting the Remuneration of Elected Municipal Officer exceeds the maximum established in section 22 of this law, the difference shall be paid to the mayor as remuneration rather than as an expense allowance.

ARTICLE 7:

The basic remuneration and the additional remuneration as established by the present By-Law will be indexed and increased, for each fiscal year following the coming into force of the present By-Law.

The indexing consists of increases, for each fiscal year, on the applicable amount for the prior fiscal year of a percentage corresponding to an increase rate in the Consumer price index for Canada as established by Statistics Canada.

When the product of the calculation foreseen in the second paragraph is not a multiple of 10, it is taken to the closest multiple of this number.

To establish the rate increase regarding the cost of living index aimed in the second paragraph:

- We subtract from the cost of living index established in the month of December of the last fiscal year by the one established with the month prior to December.
- 2) We divide the difference obtained in virtue of paragraph 1) with the index established in the month preceding December.

ARTICLE 8:

The present By-Law comes into effect on the 1st of January 2011.

ARTICLE 9:

The present By-Law will take effect in accordance with the Law.
