WHEREAS the Municipality has adopted by-law no. 282-2018 decreeing the conditions for the reimbursement of expenses of council members and employees of the Township of Harrington;

WHEREAS the Council wishes to make an amendment to said by-law;

WHEREAS a notice of motion was given by Councillor Gabrielle Parr at the regular sitting of July 9, 2018, and that said by-law was presented;

CONSEQUENTLY, it is by By-law No. 282-2-2018, entitled "By-law modifying By-law no. 282-2018 decreeing the conditions of reimbursement of expenses of council members and employees of the Township of Harrington ", decreed and enacted as follows:

ARTICLE 1: Application

The preamble to this Regulation forms an integral part thereof.

ARTICLE 2: Travel expenses

By-law no. 282-2018 decreeing the terms and conditions for the reimbursement of expenses of council members and employees of the Township of Harrington is modified by changing the paragraph of **ARTICLE** 3

"The mileage is calculated using the shortest distance, either between the municipal office and the destination or between the departure point of the trip and the destination. For elected officials, the calculation of the route must be made from the place of residence for which he was elected in the Municipality or between the starting point of the trip and the destination. Under no circumstances will the Municipality reimburse the amount paid by an employee or an elected member for a contravention of the Highway Safety Code or for a violation of a municipal By-law that would have been imposed while traveling on the account of the employer with his personal vehicle or a vehicle belonging to the Municipality."

ARTICLE 3: Coming into force

This present By-law shall come into force according to the law.
