2022-08-R148 7.6 Resolution on the bilingual status of the Municipality of the Township of Harrington

WHEREAS the Charter of the French language ("Charter") was adopted by the National Assembly of Quebec in 1977;

WHEREAS at the time of the adoption of the Charter, the bilingual status of more than 80 Quebec municipalities was recognized under the provisions of section 29.1;

WHEREAS the Municipality of the Township of Harrington has been recognized as having bilingual status since April 22nd, 1978 and wishes to maintain this status;

WHEREAS the initial provisions of the Charter allowed municipalities where a majority of residents spoke a language other than French to be officially recognized as having bilingual status under section 29.1;

WHEREAS in January 2013, the Municipality of the Township of Harrington adopted resolution 2013-01-R013 on the bilingual status of the Municipality according to article 29.1, in order to reiterate its desire to maintain its bilingual status;

WHEREAS today, 84 municipalities and 6 boroughs continue to benefit from bilingual status, including the Municipality of the Township of Harrington; **WHEREAS** Bill 96, entitled "An Act respecting the official and common language of Quebec, French" was presented to the National Assembly in May 2021 and adopted in May 2022;

WHEREAS Law No. 96 amends the Charter by inserting section 29.2 which empowers the Office québécois de la langue française to withdraw bilingual status from a municipality whose non-French-speaking population is less than 50%, and this, in cases where the Office has sent a notice to the municipality indicating that its status will be revoked if a resolution requesting the maintenance of bilingual status has not been received within 120 days;

WHEREAS according to the 2016 census, Anglophones represent just over 52% of the population of the Municipality of the Township of Harrington;

WHEREAS the census does not take into account non-permanent residents with secondary residences in rural and resort communities;

CONSEQUENTLY,

It is moved by councillor Chantal Scapino

And carried:

TO DECLARE that the Municipality of the Township of Harrington wishes to maintain the bilingual status granted to it on April 22nd, 1978 and wishes to keep it until it decides otherwise;

TO CONFIRM, with as much conviction as during the adoption of resolution 2013-01-R013 in January 2013, that the Municipality of the Township of Harrington wishes to maintain its bilingual status, regardless of any fluctuation in its population reported by the data of census;

TO REITERATE that the residents and council of the Municipality of the Township of Harrington consider the recognition of the bilingual status of our municipality as essential to the character of the municipality and as testimony to the historical presence of the two communities, English and French, in the Township of Harington;

TO DECLARE that Council considers the wording of Section 29.2 to be perfidious, depriving municipalities of the right to request the withdrawal of bilingual status when they deem it necessary and forcing them to repeatedly ask the government to maintain this privilege;

TO SEND a copy of this resolution to the Prime Minister of Canada, the Premier of Quebec, the Commissioner of Official Languages, the Federation of Canadian Municipalities (FCM), the Fédération québécoise des municipalités (FQM) and the Union Municipalities of Quebec (UMQ).

WHEREAS the Premier of Quebec, in various statements, one of which dates back to July 2020 and the other July 2021, maintains that the population of the Laurentians must be able to count on adequate health care coverage and a consolidation of the HRSJ;

WHEREAS in the perspective of the next ten years in the Quebec Investment Plan 2022-2032 (PQI 22-23), only three of the six hospitals in the region are planned to be modernized, and this, at a third of the sums necessary for their entire completion (Mont-Laurier, Saint-Eustache and Saint-Jérôme) and that nothing is planned for the three other hospitals in the region (Sainte-Agathe-des-Monts, Lachute and Rivière-Rouge);

WHEREAS the shortfall for the complete completion of the three hospital projects in progress (Mont-Laurier, Saint-Eustache and Saint-Jérôme) amounts to \$1.4 billion, in addition to the sums already provided for in PQI 22-32 for the latter (\$735m);

WHEREAS to advance the three other files of the hospital centers (Sainte-Agathe-des-Monts, Lachute and Rivière-Rouge), the Government of Quebec must follow up on the clinical plan of the Laurentian hospital and initiate the phase of the plans functional and technical for the three establishments;

WHEREAS the Government of Quebec must immediately implement, for the Laurentians region, its new Health Plan promoting, among other things, increased investments in infrastructure as well as the establishment of attractive and modern environments, accessibility to care, more fluid emergencies, an increase in the ratio of hospital beds and a major catch-up in surgeries, which are essential elements that will provide a lasting solution to the problems that citizens and staff in the Laurentians region face on a daily basis;

WHEREAS the Coalition Santé Laurentides is made up of various partners in the region (elected officials, medical and hospital representatives, post-secondary institutions, seniors' associations, business and community organizations) wishing to collaborate with the Government of Quebec in order to find these sustainable and innovative solutions that pass the correction of historical budgeting as well as the complete completion of the modernization and expansion of the six hospital centers in the region thanks to a massive investment in hospital infrastructure;

WHEREAS 2022 is an election year and the importance of the health file for the Laurentians region does not benefit from national coverage allowing it to promote the importance of its health and social services,

while the Laurentians form the 4th region in demographic importance in Quebec;

WHEREAS the CPÉRL has reiterated its support for the Coalition Santé Laurentides for the year 2022, through the presence of the prefects (Antoine-Labelle, Laurentides and Deux-Montagnes) and the contribution of \$30,000 to support actions aimed at catch-up finance spending on health and social services in the region and the acceleration of projects to modernize its hospitals;

WHEREAS the City of Saint-Jérôme and the Council of Physicians, Pharmacists and Dentists of the CISSS des Laurentides are financial partners for the year 2022 (contribution of \$20,000 and \$30,000 respectively);

CONSEQUENTLY,

It is moved by councillor Chantal Scapino

And carried:

THAT the Council of the Municipality of the Township of Harrington supports the Coalition Santé Laurentides and its demands by adding its voice to those of the Council of the MRC d'Argenteuil, the Council of Prefects and Elected Officials of the Laurentians Region (CPÉRL) and laurentiens partners in order to:

- That the Laurentians region be prioritized now in the implementation of the Government of Quebec's Health Plan with the necessary budget to fund all health and social services needs in the Laurentians;
- That the Government of Quebec correct the historical health budgeting which continues to penalize the Laurentians region;
- That a complete completion of the six hospital centers of the Laurentians region allowing their modernization and expansion be carried out by the end of the decade, thanks to a massive investment by the Government of Quebec in the Laurentian hospital infrastructures.
