WHEREAS the Partnership 2020-2024: For even stronger municipalities and regions was concluded on October 30th, 2019 with municipal representatives;

WHEREAS by-law project 47, An Act to ensure the implementation of certain measures of the 2020-2024 partnership between the Government of Quebec and the municipalities, was assented to at the National Assembly on December 11th, 2019, thus creating the Region and Rurality Fund (FRR);

WHEREAS the intermunicipal cooperation axis of component 4 – Support for revitalization and intermunicipal cooperation, aims to encourage collaboration between municipal organizations by increasing the number of intermunicipal cooperation projects allowing the improvement of services offered to citizens;

WHEREAS by intermunicipal cooperation, it is understood in particular the pooling of professional resources, and this, under an intermunicipal agreement;

WHEREAS the municipality of the Township of Harrington has taken note of the Guide for organizations concerning component 4 – Support for intermunicipal cooperation of the Regions and Rurality Fund;

WHEREAS the MRC d'Argenteuil is currently reviewing its Residual Materials Management Plan (PGMR);

WHEREAS according to the findings from the working committee and the pre-consultation meetings held in the spring of 2022 with the people responsible for managing residual materials in the local municipalities,

the actions that will be targeted in the next PGMR 2023-2030 must be much more elaborate, for example:

- Stimulate the performance of the collection of recyclable and organic materials among vacationers, tourist sites and among residents who live in multi-dwellings (eg: green brigade, etc.);

- Set up new residential collection services for organic matter (ex.: door-to-door, voluntary drop-off, etc.);

- Develop solutions for the disposal and processing of collected materials;

- Continue individual and personalized support for industries, businesses and institutions (ICI);

- Improve communication tools with citizens and ICI;

WHEREAS municipalities will therefore face several challenges in order to achieve government objectives and that a resource dedicated to municipalities in the implementation of local initiatives would be highly desirable;

WHEREAS the constituent municipalities of the MRC d'Argenteuil wish to submit an intermunicipal cooperation project within the framework of financial assistance, allowing the sharing of a professional resource in the management of residual materials employed by the MRC;

WHEREAS the MRC d'Argenteuil has multidisciplinary expertise, particularly in environment, communication, land use planning and geomatics, capable of coordinating and supporting a local professional resource in the management of residual materials;

WHEREAS according to the rules and standards of the program, with its economic vitality index positioning the MRC d'Argenteuil in the fourth quintile of the MRCs of Quebec, the financing of this resource could reach 80% of eligible costs (salary, social benefits and other), until 2026, up to a maximum amount of \$250,000;

CONSEQUENTLY,

THAT the council of the Municipality of the Township of Harrington authorizes the submission of a project by the MRC d'Argenteuil, aimed at sharing a professional resource in residual materials management hired by the MRC, in order to implement actions that concern each local municipalities under component 4 - Support for intermunicipal cooperation of the Regions and Rurality Fund;

THAT council undertakes to participate in the project and assume part of the costs, jointly with the constituent municipalities of the MRC d'Argenteuil which will participate in the project;

	THAT council appoints the MRC d'Argenteuil as the organization responsible for the project and asks it to submit a request for financial assistance under this Program;
	THAT in the event of the acceptance of said request for financial assistance, the terms and conditions will be the subject of an intermunicipal cooperation agreement to be concluded between the MRC d'Argenteuil and the constituent municipalities of the MRC d'Argenteuil that will participate in the project.
