## PUBLIC NOTICE DRAFT BY-LAW NUMBER 355-2024 CONCERNING THE WAGES OF ELECTED MUNICIPAL OFFICIALS

## **IS HEREBY GIVEN BY THE UNDERSIGNED, THAT:**

In accordance with Section 9 of the Act respecting the salaries of elected municipal officials, draft by-law number 355-2024 respecting the salaries of elected municipal officials was tabled and presented to Council at the regular meeting of March 18, 2024.

The draft regulations can be summarized as follows:

- The draft regulations can be summarized as follows: Draft by-law 355-2024 modifies only the remuneration of the mayor, since in December 2022, when by-law 296-2022, wages of elected municipal officials was adopted, there was a vacancy in the position of mayor. The remuneration and regular expense allowance of councillors and the deputy mayor are therefore not affected by this by-law.
- The proposed remuneration for the mayor is \$27,580 (current \$20,668). No remuneration will be paid for committee meetings.
- The mayor will be entitled to an expense allowance equal to half the amount of remuneration, up to the maximum provided for in section 19 of the Act. This amount is \$13,780 (currently \$10,334). No expense allowance will be paid for committee meetings.
- The proposed remuneration will be indexed for each fiscal year by a percentage corresponding to the rate of change in the consumer price index for the previous year, taking as a base the index established for the whole of Quebec by Statistics Canada.
- In the event that the acting mayor replaces the mayor for more than thirty days, the acting mayor will be entitled, from that time until the replacement ceases, to a sum equal to the mayor's remuneration during that period.
- Elected councillors' salaries will be paid monthly.
- The regulation will be retroactive to January 1, 2024.
- Repeals and replaces by-laws number 284-2018 and 296-2022.

The by-law will be presented to Council for adoption at the regular meeting of May 21, 2024, to be held at 7:00 p.m. at the Lost River Community Centre, located at 2811 Route 327.

Draft by-law #355-2024 is available for consultation on the municipal website and at the municipal office during regular business hours.
