ARTICLE 1 - PREAMBLE

The preamble forms an integral part of the present by-law.

ARTICLE 2

The by-law constituting the Planning Advisory Committee 196-2012, as amended, is modified in article **2.4.4** "Remuneration of members", by replacing the first paragraph which will read as follows:

"2.3.4: Remuneration of members

Committee members receive no remuneration. They may, however, receive an attendance allowance set by the City Council".

- Development of a rest area along the banks of the Beaven River falls
