INFORMATION REQUIRED FOR THE UNDERGROUND WATER CATCHMENT FOR A WELL

The request must be accompanied by the following documents and information:

1. A copy of the quote prepared by the company doing your groundwater catchment.
2. A **plan drawn to scale showing the location of the work** and its pumping capacity as well as the building location, property lines, septic installation of the applicant and those of the adjacent lands, lakes and water course, embankments, trees and shrubs, pasture, breeding facility or any location where there is animals.
3. The Company that has dug the underwater catchments work has, in the thirty days that follow the end of the work, prepare a drilling report testifying the accordance of the work of the water catchments, in accordance with the presentation model furnished by the ministry of the Environment and within this delay furnish a copy to the Municipality.
4. The owner of the water catchments work must between the second and thirtieth day following the installation of the pumping equipment, take a water sample and have a microbiological and physical chemistry parameters analyzed.
