Waste Management

EVERY ACTION COUNTS



By sorting your waste correctly and placing it in the appropriate bin (recycling or composting), you help protect the environment and reduce costs for your municipality.

Fire Prevention

Ashes must be cooled

for at least 72 hours

before being placed in the compost.

Organic materials



Composting helps reduce costs for the municipality and keeps your waste-related taxes as low as possible.

Is it edible or part of something that is edible?

Raw, cooked, or spoiled: All meal preparation scraps and table leftovers in paper bags or loose only.

2 Is it paper or cardboard?

Paper or cardboard soiled by food or used to package food.

3 Is it garden waste?

Cut grass, dead leaves, garden bed residues, cones and needles from conifers, straw, hay, potting soil and compost, untreated wood chips, etc.

4 Other

Cold ashes, hair and feathers, natural corks, litter, wooden toothpicks, etc.

PLEASE NOTE THAT NO PLASTIC BAGS WILL BE ACCEPTED IN THE COMPOST BINS.

Recyclable materials



Recycling helps reduce costs for the municipality and keeps your waste-related taxes as low as possible.

CONTAINERS - Flexible or rigid, containers can be made of paper, cardboard, glass, plastic or metal. How to spot them: recyclable containers usually have a cap or lid.

PACKAGING - Like containers, packaging items are made of paper, cardboard, plastic, glass or metal. How to spot them: they're used to easily transport a product.

PRINTED PAPER - These are papers and other fibres on which texts, patterns or images are sometimes found.

Household waste



Landfilling waste generates significant costs for the municipality, which results in higher waste-related taxes for residents.

- It is strictly prohibited to place construction materials or bulky items in household waste. You must dispose of these items at the Ecocentre.
- Branches are accepted only if they are tied into small bundles.

Residential Pool Safety By-Law

The Residential Pool Safety By-law now applies to all outdoor residential pools, hot tubs, and spas. This By-law concerns bodies of water that are 60 cm deep or more, or have a volume greater than 2,000 liters, whether they are above ground, in-ground, or even removable (inflatable or otherwise).

Owners of pools installed before November 1, 2010, who previously had an exemption, now have until <u>September 30</u>, 2025, to bring their installations into compliance.

The septic tank must be emptied every two years for permanent residences and every four years for seasonal residences.

Water Testing



You are invited to a day of water testing and information on drinking water. For the occasion, the Notreau Caravan will be on site to offer discounted well water testing. Professionals will also be available to answer your questions about well maintenance and operation.

Sterile bottles are now available at Town Hall during our business hours.

Basic Test (Potability) - \$45, taxes included

Total and fecal coliforms, as well as atypical bacteria.

Advanced Test (Potability + Dissolved Ions) - \$100, taxes included

Total and fecal coliforms, atypical bacteria, alkalinity, conductivity, pH, iron, manganese, turbidity, and total hardness.

Please note that additional water parameters can also be tested for an extra fee, such as cyanobacteria, iron bacteria (iron ochre), and more.

Boat Washing Station

2811, route 327, Harrington (at the Lost-River fire station)





Each time you visit a new body of water, it is mandatory to wash your boat and equipment at the washing station in order to preserve the quality of our lakes and rivers.

Any person who fails to comply with this obligation is liable to a fine of \$500 to \$2,000, imposed by the municipality.

Washing Certificate





The certificate printer at the boat washing station has been operational since this spring.

After washing your boat for at least 5 minutes, you'll automatically receive a washing certificate in the form of a printed coupon. This certificate confirms that you've properly used the station

How the system works

- Press the button to activate the washer.
- 2. Wash your boat.
- 3. Once finished, collect your printed certificate from the machine.



Fraud Prevention

The Sûreté du Québec is currently investigating a fraud case involving an individual who solicits roofing contracts, completes the work, then returns offering paving services. The suspect requests a deposit and then disappears without completing the job. The suspect's phone is subsequently disconnected.

Stay vigilant, and remember that any information related to criminal activity can be reported to the Sûreté du Québec's Criminal Information Center at 1-800-659-4264.

Tick Prevention Tips

- Stay on trails and avoid tall grass;
- Use insect repellent on exposed skin:
- Wear a hat, closed-toe shoes, and long clothing;
- Tuck your shirt into your pants and your pants into your socks or boots
- Wear light-colored clothing during walks. Light colors make ticks easier to spot.
