PUBLIC NOTICE

TO PERSONS ENTITLED TO VOTE WHO HAVE THE RIGHT TO BE INCLUDED ON THE REFERENDUM LIST FOR THE ENTIRE MUNICIPALITY

Pursuant to section 533 and following the Municipal Law on elections and referendums, a public notice is hereby given of the following:

- 1. At a regular sitting of Council held on November 17st, 2025, the Municipality Council adopted the following by-law entitled: "LOAN BY-LAW NUMBER 380-2025, DECREEING A TOTAL EXPENDITURE OF \$855 686 AND A LOAN OF \$554 123 FOR WORK ON THE LOST RIVER DAM (Dam no. X0004953)
- 2. Qualified voters who are entitled to be registered on the Municipality's referendum list may request that loan by-law number 380-2025 be subject to a referendum poll by entering their name, address and status and signing in a register opened for this purpose.
 - Eligible voters wishing to register their name must present an identification card: Medicare card, driver's licence, passport, Certificate of Indian Status or Canadian Forces identification card.
- 3. The register will be accessible from 9 a.m. to 7 p.m. on November 27th, 2025, at the office of the Municipality of the Township of Harrington, located at 2940 Route 327 in Harrington as well as on our Municipal website.
- 4. The number of requests required for By-law 380-2024 to be put to a referendum vote is 341. If this number is not reached, by-law number 380-2024 will be deemed approved by those eligible to vote.
- 5. The result of the registration procedure will be announced at 7:15 p.m. on November 27th, 2025, at the Harrington Municipality office located at 2940 Route 327 in Harrington.
- 6. The by-law may be consulted at the office of the Municipality of Harrington, 2940 Route 327 in Harrington, Monday to Friday between 8:30 a.m. and 12:00 p.m. and between 12:30 p.m. and 4:00 p.m.

Conditions to be a qualified voter entitled to be registered on the Municipality's referendum list:

7. Any person who, on November 27th, 2025, is not disqualified from voting under section 524 of the Act respecting elections and referendums in municipalities and meets the following conditions:

- be a natural person domiciled in the Municipality and have been domiciled in Québec for at least 6 months; and
- be of legal age, a Canadian citizen and not under guardianship
- 8. Any non-resident sole proprietor of a building or non-resident sole occupant of a business establishment who is not disqualified from voting and meets the following conditions:
 - be the owner of a building or sole occupant of a business establishment located in the Municipality for at least 12 months;
 - be of legal age, a Canadian citizen and not under guardianship
- 9. Any non-resident undivided co-owner of a building or non-resident co-occupant of a business establishment who is not disqualified from voting and meets the following conditions:
 - have been an undivided co-owner of a building or co-occupant of a business establishment located in the Municipality for at least 12 months;
 - be designated, by means of a proxy signed by the majority of persons who have been coowners or occupants for at least 12 months, as the person entitled to sign the register on their behalf and to be entered on the referendum list, if applicable. This proxy must have been produced before or at the time of signing the register.
- 10. Legal person
 - having designated by resolution, from among its members, directors or employees, a person who, on November 27th, 2025 and at the time of exercising this right, is of full age and a Canadian citizen, is not under guardianship and is not disqualified from voting by law.
