DRAFT BY-LAW NO. 388-2026 - Amending BY-LAW NO. 374-2025, authorizing a total expenditure of \$7,334,711 and a loan of \$1,833,678 for work on Chemin de la Rivière-Rouge

CONSIDERING THAT, on June 6, 2025, the Council adopted Borrowing By-law No. 374-2025, authorizing a total expenditure of \$7,334,711 and a loan of \$1,833,678 for work on Chemin de la Rivière-Rouge.

CONSIDERING THAT said By-law was approved by the Ministry of Municipal Affairs on February 9, 2026, under file number M609211.

CONSIDERING THAT Borrowing By-law No. 374-2025 established a 10-year term for the loan.

CONSIDERING THAT the Council wishes to extend the term of the loan to 20 years.

CONSIDERING THAT By-law No. 374-2025 must be amended to allow for the extension of the loan term.

CONSIDERING THAT notice of motion for this by-law was given at a regular sitting of the Council held on March 16, 2026, at which a draft of By-law No. 388-2026 was tabled.

AND CARRIED by this By-law numbered 388-2026 and entitled BY-LAW NUMBER 388 -2026 AMENDING THE BY-LAW DECREERING AN EXPENSE OF \$7,334,711 AND A LOAN OF \$1,833,678 FOR WORK ON CHEMIN DE LA RIVIÈRE-ROUGE.

THE COUNCIL decrees as follows:

SECTION 1

The preamble forms an integral part of this by-law.

ARTICLE 2

Section 4 of By-law No. 374-2025 is replaced by the following:

“For the purpose of paying the expenditures provided for in this by-law, the Council is authorized to borrow the sum of \$1,833,678 over a period of 20 years.”

ARTICLE 3
